2026 EAST VALLEY WOMAN & MAN OF THE YEAR AWARDS



This year, we award **East Valley's Woman of the Year** to **Kathleen Dowler**. Kathleen has dedicated her profession, time, and energy to advocating for and empowering East Valley women. She has been a trailblazer for her projects and initiatives – most of which have been dedicated to serving women in need. Kathleen's leadership and impact extend significantly beyond her work as a Positive Paths' former board president. Through her leadership role at Dignity Health and her volunteer task force roles—including the creation of the Gilbert Advocacy Center—her impact extends to women and their families with the goal to create self-sufficiency.

Her nonprofit work and leadership across multiple organizations are beyond what we see in many leaders who are involved in community outreach. Kathleen truly is impressive and deserving of this award.

Our outstanding **East Valley Man of the Year award** goes to **Rudy Apodaca**. Rudy has exhibited impressive support for East Valley women for more than 50 years. He actively supported underserved women with part-time jobs and full time pay to pursue medical careers through his connection with Dignity Health. He has supported initiatives around stroke certification and certified trainers in East Valley school districts to support female athletes. Other support includes Stroke Camp, free mammograms, robust engagement in after school programs, scholarship programs, and significant personal donations to causes supporting women in the East Valley. Rudy is an exceptional person, kind and competent. He has initiated and supported many important community programs that support women in need through Dignity Health, the East Valley Hispanic Chamber, ICAN, the Chandler Education Foundation, the Gilbert and Queen Creek Chambers, and other organizations.



Returning Emcee Kathleen Mascarenas is a household name for many in the Valley of the Sun. She is best known for managing media relations for the Arizona Super Bowl XLIX, for 15 years of managing media relations for SRP, being a long-time television reporter and anchor, and for being the 22-year owner of Mas Video Productions and Public Relations.



Also joining us again is professional auctioneer Jesse Staton who is well known in the auction circuit as the Rodeo Queen and will lead our live auction with prizes too big for the silent auction. Her spirited skills were popular among last year's auction participants, and she is eager to join us again.
